A study on the classification of China's provincial carbon emissions trading policy instruments: Taking Fujian province as an example

ABSTRACT

In order to reduce greenhouse gas emissions, China's provinces have issued a series of carbon emission trading policies in recent years. As China's first ecological civilization demonstration zone, Fujian Province has also promulgated an array of carbon emission trading policies. Therefore, deeply analyzing the classification of carbon emission trading policies in Fujian Province is of great reference value for other regions to formulate carbon emission trading policies. This paper first introduces the textual formulation of the carbon emission trading policies in Fujian Province, and subdivides the relevant policies into 17 types of policy instruments as per the classification criteria of mandatory, hybrid, and voluntary. Besides, it also classifies and codes the instruments involved in the Fujian provincial carbon emission trading policies using social network analysis method, with a total of 107 social network actors obtained. On this basis, the differences in the composition of various policy instruments are to be compared and analyzed. The Results show that the proportions of mandatory policy instruments, hybrid policy instruments, and voluntary policy instruments are 54.20%, 36.45%, and 9.35%, respectively. The policy instruments used by the Fujian provincial government are dominated by mandatory and hybrid policy instruments, and the voluntary policy instruments account for a relatively low proportion. Currently, what the Fujian government's carbon emissions trading policies focus on is to improve the supervision and accountability mechanism so as to form a complete carbon emission trading supervision and management system. In the process of building a carbon emissions trading market, the government of Fujian Province should strengthen policy support for talent cultivation, carbon credit evaluation system construction, and policies support for projects in finance, and reinforce the construction of voluntary certification emission reduction mechanism in a timely manner, with a view to encouraging the participation of social forces in the construction of the carbon emissions trading market.

1. Introduction

In recent years, China has paid great attention to building a carbon emission trading market. In the "Twelfth Five-Year Plan", it was clearly stated that market-based means such as carbon emission trading should be fully used to control greenhouse gas emissions. In October 2011, the National Development and Reform Commission of China issued the Notice on Pilot Carbon Emissions Trading Project, and approved to launch the pilot projects of carbon emission trading in seven provinces and municipalities including Beijing, Tianjin, Shanghai, Guangdong, Hubei, Shenzhen and Hebei. In December 2016, Fujian Province became China's eighth pilot region for carbon emissions trading. Appendix shows

the construction of the carbon emissions trading market in each region.

In terms of industry coverage, Fujian Province has included nine industries – ceramics, aviation, power, chemicals, and building materials, for example – into the carbon emissions trading market system. In terms of corporate access standards, Fujian Province has set the access standard of the total energy consumption amounting to more than 10,000 tons of standard coal at any year in 2013 to 2015. In terms of quota management, Fujian Province chose to adopt a free distribution method at the initial stage, and has introduced a paid distribution mechanism at an appropriate time, ultimately increasing the proportion of paid distribution step by step. As to free quota accounting, in combination with the historical emission method and baseline method, the market trading methods like open bidding and agreement transfer have been introduced, while the main participants in the market include pilot enterprises, approved organizations

and institutions, and natural persons. With regard to the punitive measures for non-performance of settlement and payment, the government supported and introduced professional third-party verification agencies to monitor the carbon emissions of enterprises. Furthermore, to prevent enterprises from completing emission reduction tasks only by purchasing carbon credits, Fujian Province has set a limit of no more than 10% for Chinese Certified Emission Reduction (CCER) offset ratio, requiring a fine of 1 to 3 times the average market price for the non-performed part, but the penalty amount does not exceed 30,000 yuan. (As shown in Appendix)

As China's first ecological civilization demonstration zone and the 8th carbon emission trading pilot area, Fujian Province has issued an array of policy documents like Implementation Plan of Fujian Province Carbon Emissions Trading Market Construction and Interim Measures for Fujian Province Carbon Emissions Trading Management, which are involved in a number of policy instruments. Therefore, its policy practices are of important enlightening significance and great reference value for other regions of China. However, as of now, although there have been some studies focusing on the topic of China's provincial carbon emissions trading, most of them aim at the necessity of establishing China's carbon emission trading market (Zhu et al., 2016; Department of Eco-Environmental Response to Climate Change, 2018; Jingi, 2018; Shuang, 2014), the quota design of carbon emission permit (Jotzo and Löschel, 2014; Zhaoxia and Shian, 2018; Mengshu, 2011; Fan, 2018; Kehui, 2015; Li and Fenggiao, 2016; Rui, 2016), or the institutional design of China's carbon emission trading market (Xiaotao and Xue, 2010; Bowen, 2018; Haiyun and Tao, 2013; Li et al., 2012; Lei and Yonggiang, 2019) and the problems existing therein (Jiemin, 2013; Xiaoling and Chuiming, 2018; Chao et al., 2016; Xingyan, 2016; Zhongyu and Zhixiong, 2018), with few getting engaged in China's provincial carbon emission trading policy instruments. In view of the above, this paper, taking Fujian Province as an example, explores its use of carbon emission trading policy instruments, and strives to comparatively analyze the differences in the composition of various policy instruments involved in the carbon emission trading policies of Fujian Province on the basis of classifying policy instruments into the three types of mandatory, hybrid, and voluntary.

2. Methods and data

2.1. Methods

This paper carries out text mining and comparative analysis of Fujian carbon emission trading policy documents using social network analysis (SNA) method. SNA defines social structure and relationships as a network that quantifies the relations between actors in the social network, focusing more on finding the relations between actors and exploring the influence of the relationship on the whole network (Borgatti, 2003; Peng et al., 2015; Qinghua and Liang, 2008). Therefore, it is a relatively mature quantitative analysis method for public management issues, and has enjoyed a broad application prospect in the field of public management and policy analysis (Aggarwal, 2011; Ahmadi et al., 2019; Borgatti et al., 2009; Sandström and Carlsson, 2008; Weihua, 2015a,b). In SNA, a social network is a collection of multiple points (social network actors) and connections between the actors (the relations between actors). As a result, it has been widely used in a large number of literature, in which the text content of public policies are studied with tool software such as UCINET (Yi et al., 2018; Hailin and Cuihong, 2018; Lewis, 2006). The general practice is first to sort out the relevant policy documents to spot the policy instruments to be viewed as the actors in the social network after coding, and then to map the

policy instruments spotted with the Netdraw tool provided by Ucinet software and based on the SNA method.

UCINET has the NetDraw function, which can visualize data, as shown in Fig. 3. After continuous upgrade and update from Basic language, Dos program to Windows system, it was upgraded to version 6.0 in 2002 and has been undergoing continuous upgrade. With the help of UCINET software, this paper teases out the policy instruments involved in the carbon emission trading policy documents of Fujian Province that are taken as social network actors and mapped, and analyzes the classification characteristics of the policy instruments on the basis of the mapping.

2.2. Data

This paper collects and sorts the 17 policy documents followed by the carbon emissions trading activities in Fujian Province since 2015, which are taken as the analysis samples of the policy texts. Based on the existing classification criteria of policy instruments (Rochefort, 1997), the carbon emission trading policy instruments of Fujian Province are divided into three categories, namely mandatory, hybrid and voluntary according to the strength of government administrative intervention. Among them, the mandatory policy instruments can be subdivided into 8 categories, including access mechanism construction, information reporting and verification, quota allocation and management, trading platform operation and maintenance, contract performance and settlement, carbon credit evaluation, supervision and accountability, and information disclosure. The hybrid policy instruments can be subdivided into 7 categories, including flexible quota adjustment mechanism construction, enrichment of carbon financial products and investment and financing channels, financial subsidies, increase of financial support, publicity and education training, priority to the application of financial fund support projects, and professional talent training. The voluntary policy instruments can be subdivided into 2 categories, namely construction of voluntary certification emission reduction mechanism and encouragement to social force participation. (As shown in Tables 1 and 2)

Among the 17 policy documents collected, there are only Policy documents 3 and 4 covering all the policy instruments, and the remaining 15 policy texts cover different policy instruments. This suggests that the policies issued by the government have different priorities in the use of the policy instruments. For example, Policy documents 1 covers seven policy instruments, of which hybrid policy instruments occupy a relatively high proportion, indicating that in Policy documents 1, the government prefers to use hybrid policy instruments to strengthen carbon emissions trading management. (As shown in Table 2)

The policy instruments involved in the selected 17 policy documents ranked as per the time of issuance can be coded into 107 actors in the social network, and the coding follows the principle of "actor serial number + policy file code + policy instrument number" (as shown in Table 3). Take the actor coded "1A(7)" in Table 3 as an example, where 1 indicates the actor serial number, A is the code of the policy file involving the actor (see Table 2 for details), and (7) stands for that the actor gets involved in the No.7 policy instrument (see Table 1 for the policy instrument number).

3. Results and discussions

3.1. Results

The 107 social network actors (see Table 3) formed as per the classification of policy instruments can form a relationship matrix of the actors in the Fujian Carbon Emissions Trading Policy Instrument Network (if two actors belong to the same category of policy

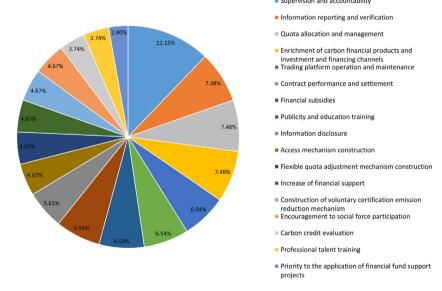


Fig. 1. Proportion of social network actors contained by different carbon emissions trading policy instruments.

instrument, it is to be marked as "1" in the corresponding position of the relationship matrix; or otherwise it is "0"). The matrix is imported into the social network method analysis tool UCINET6.0, so that the social network map of various policy instruments can be drawn (see Fig. 3). There are 17 maps drawn in total. The number of social network actors included in each of the 17 policy instrument networks is shown in Table 4, and they can be ranked from high to low as per their proportion, namely: mandatorysupervision and accountability, mandatory-information reporting and verification, mandatory-quota allocation and management, hybrid-enrichment of carbon financial products and investment and financing channels, mandatory-trading platform operation and maintenance, mandatory—contract performance and settlement, hybrid-financial subsidies, hybrid-publicity education and training, mandatory-information disclosure, mandatory-access mechanism construction, hybrid-flexible quota adjustment mechanism construction, hybrid-increase of financial support, voluntary—construction of voluntary certification emission reduction mechanism, voluntary-encouragement to social force participation, mandatory—carbon credit evaluation, hybrid-professional talent training, and hybrid-priority to the application of financial fund support projects. The number of social network actors covered is 13, 8, 8, 8, 7, 7, 7, 7, 6, 5, 5,

5, 5, 4, 4, 3, respectively, and the proportion accounted for in the total social network actors is 12.15%, 7.48%, 7.48%, 7.48%, 6.54%, 6.54%, 6.54%, 6.54%, 6.654%, 4.67%, 4.67%, 4.67%, 4.67%, 4.67%, 3.74%, 3.74%, 2.80%, respectively (see Fig. 1). Fig. 3 is a visual representation of the number of social network actors involved in the 17 policy instrument networks.

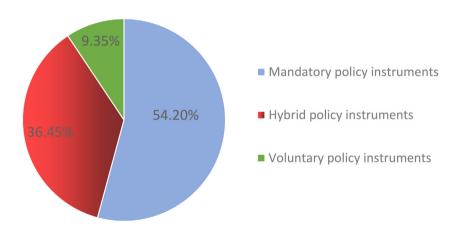


Fig. 2. Proportion of different types of carbon emissions trading policy instruments.

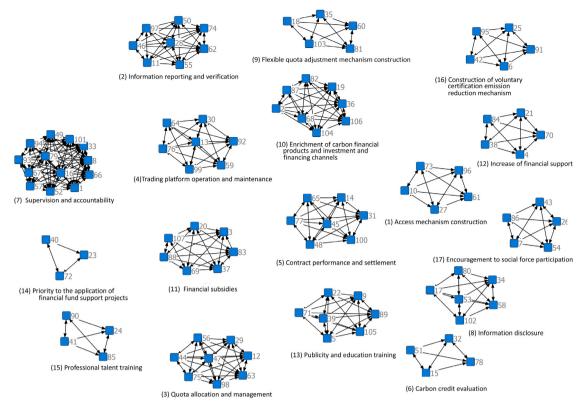


Fig. 3. Policy network map of Fujian provincial carbon emission trading system.

Among the 17 policy instruments, mandatory-supervision and accountability is the most frequently used, while hybridpriority to the application of financial fund support projects is the lowest frequently used, with the use frequency of the former significantly higher than other policy instruments. As can be seen from Fig. 2, among the 107 actors, the proportions of mandatory, hybrid, and voluntary policy instruments are 54.20%. 36.45%, and 9.35%, respectively. As shown in Fig. 3, compared with voluntary policy instruments like construction of voluntary certification emission reduction mechanism and encouragement to social force participation, mandatory policy instruments like supervision and accountability, information reporting and verification, quota allocation and management, trading platform operation and maintenance, and contract performance and settlement see more intensive sub-network maps. The reasons may be ascribed to the short construction time of Fujian's carbon emission trading market, needing-to-be-standardized operation

standards, and stronger binding effectiveness of mandatory and hybrid policy instruments than voluntary ones, for mandatory and hybrid policy instruments can play a more intense normative role in the construction of the carbon emissions trading market.

In the process of using policy instruments, the government pays more attention to the comprehensive supervision of the carbon emission trading market, so as to ensure the rational allocation of carbon emission quotas. It is worth noting that carbon credit evaluation, priority to the application of financial fund support projects, and training of professional talents are important links in the construction of carbon emission trading market, which is of great significance for promoting the development of carbon emission trading market in Fujian Province, but these three policy instruments involve a small number of social network actors, and thereby need to be improved.

3.2. Discussions

It can be discovered that mandatory—supervision and accountability instrument is the most frequently used among the 17 policy instruments. Why is the government so keen to promote the development of the carbon emission trading market through the supervision of accountability instrument during the construction of the carbon emission trading market in Fujian Province? This is mainly because the use of supervision and accountability instrument can form a powerful deterrent in the construction of the carbon emission trading market. Meanwhile, it can make the implementers of policy instruments more self-binding and ensure that the market transactions are conducted fairly.

Mandatory and hybrid instruments account for 90.35% of the total number of policy instruments used. This strongly reflects the

government's preference on use of the 17 policy instruments in Fujian Province. But whether the government is excessively involved in the development of the carbon emission trading market is still worth further discussion.

This paper uses three types of policy classification methods including mandatory, hybrid and voluntary in the classification of carbon emission trading policy instruments in Fujian Province, but in fact, other policy instruments classifications can be considered for provincial carbon emission trading policy instruments. In addition, this paper uses social network analysis to study policy texts and policy instruments, but other methods, such as qualitative analysis, can also be applied to this study.

4. Conclusions

In the construction of the carbon emission trading market in Fujian Province, compulsory, hybrid and voluntary policy instruments were comprehensively utilized, but there were significant differences in the component ratio of the policy instruments. In the process of using policy instruments to promote the development of the carbon emission trading market, Fujian government tended to use mandatory and hybrid policy instruments rather than voluntary ones. Therefore, perfecting the supervision and accountability mechanism to form a complete carbon emission trading supervision and management system is the focus of the current Fujian government's carbon emissions trading policy. In

the process of building a carbon emission trading market, Fujian government should increase policy support for talent cultivation, strengthen the training of relevant professionals engaged in carbon emissions trading, and support and encourage the wide-ranging cross-system, interdisciplinary, cross-sectoral and inter-regional cooperation and exchanges among universities, research institutes, enterprises in the industry, and government departments, in an attempt to cultivate a batch of professionals who are capable of and interested in devotion to this field, accelerate carbon credit evaluation system construction, uplift financial and policy support, and strengthen the construction of voluntary certification emission reduction mechanism in a timely manner, with a view to encouraging social forces to actively participate in the construction of carbon emissions trading market.

The result of this paper shows that the policy instruments with binding nature are widely used in the construction of the carbon emission trading market in Fujian Province. It is mainly due to the fact that the carbon emission trading market in Fujian Province is still in the primary construction stage. Although the use of compulsory and hybrid policy instruments is positive for promoting market development, attention should also be paid to prevent the risks of excessive interventions in the development of the carbon emission trading market. The development of the carbon emission trading market in Fujian Province needs to be realized through the comprehensive use of various policy instruments.
