In its 17th year, *EJEEP* continues to provide a forum for pluralist debates of current topics in economics and economic policies, as well as discussions of eminent publications and authors of the heterodox camp. This issue is no exception to this rule. In the forum section, Emiliano Libman critically appraises the recent textbook *Heterodox Macroeconomics: Models of Demand, Distribution and Growth* by Robert A. Blecker and Mark Setterfield. The authors of the book respond in the same section, using Libman's comments as a starting point to develop and explain the concept of the book further. The forum section also includes an interview with the well-known pluralist economist Amitava Dutt, who explains why he prefers to call what he is doing political economy or socio-political economy, and not necessarily post-Keynesian economics. We would like to thank Stefan for his support and his contributions to this journal.
